The general nature of the improvement consists of four individual project locations where conservation practices (oxbows and ponds) will be constructed in accordance with lowa NRCS Standard Specifications and the project special specifications. The projects will be constructed on agricultural or municipal land within the Upper Wapsipinicon River Watershed located in Buchanan County, Iowa as part of the Iowa Watershed Approach. The scope of work includes, but is not limited to: mobilization, site preparation, topsoiling, core trench excavation, embankment construction, corrugated metal pipe procurement and installations, rock rip-rap procurement and installation, tile investigation, removal, and installation and seeding, mulching and fertilizing. The four projects will be split into two separate bid schedules as shown in Section 7 (Proposal Form). Each Bid schedule will have its own separate contract. Each contract will be awarded to the lowest responsive and responsible bidder for each bid schedule. It is possible that the two contracts could be awarded to two different contractors or both could be awarded to the same contractor if they are the lowest responsive and responsible bidder for both bid schedules.

The engineer's opinion of probable cost for Bid Schedule 1 projects is approximately \$107,000 and The engineer's opinion of probable cost for Bid Schedule 2 project is approximately \$205,000.

Bid security shall be in the form of a cashier's check or a certified check, drawn on an FDIC insured bank in lowa or drawn on an FDIC insured bank chartered under the laws of the United States; or a certified share draft drawn on a credit union in lowa or chartered under the laws of the United States; or a bid bond executed by a corporation authorized to contract as a surety in lowa or satisfactory to the Jurisdiction.
